Approval of Salary Increase and Merit Bonus Award

On January 20, 2018, the Compensation Committee (the “*Committee*”) of Versartis, Inc. (the “*Company*”) approved a salary increase for Kevin Haas, the Company’s principal accounting officer, raising his base salary from \$250,800 per year to \$270,800 per year. The Committee also approved a 2017 merit bonus award related to 2017 performance for Jay P. Shepard, the Company’s Chief Executive Officer, in the amount of \$94,500.
